**Student responsibilities in examinations (effective S1 2009):**

All students are required to be in possession of their **Curtin Student ID** card when sitting examinations. Students without their Curtin Student ID card will not be permitted entry to the examination venue, and will be directed to Student Services to obtain a Curtin Student ID card.

Students found to be in possession of a mobile phone, or other device (other than an approved calculator) capable of storing text or restricted information, will be subject to a fine of **RM100**. A sanction, preventing the student from viewing results or graduating, will be placed on the student's record until the fine is paid.

Students who attend a venue different to that which is designated on the final examination timetable will be subject to a fine of **RM25**. A sanction, preventing the student from viewing results or graduating, will be placed on the student's record until the fine is paid.

**Display of time intervals in venues and personalised timetables (effective S2 2009):**

**A written schedule showing time intervals will no longer be displayed in examinations.** All examination venues have accurate clocks, and supervisors will advise students of the time allowed for each examination and will also make an announcement when 15 minutes of the examination remain. All students have been advised of this new arrangement via an official communication.
